APPROVAL OF PHOTOVOLTAIC SYSTEM FOR THE MAUNA LUAN

A note to let all of our residents know that the Board of Directors has entered into a contract to have a photovoltaic solar system installed at the Mauna Luan to generate electricity and help with our utility bills. We are in the process of obtaining the consent from our owners to build the support structure that will hold the solar panels. We will hopefully have that consent within the next few months. Once that is obtained, our contractor will be finishing up their planning and begin the construction. The support structure will sit atop the East uncovered parking deck. We will need to relocate vehicles during the work so we will begin notifications as soon as we know the details of the work. If there are any questions, please contact the Management Office.

FREE WI-FI SERVICE FOR LOBBY AREAS

We wanted to notify all residents that we now have free Wi-Fi service available in our two lobby areas for residents to use. Any resident who wishes to use this service must come by the Management Office to obtain the sign-in password for the network. We do have a use policy that will need to be signed for and accepted prior to being provided the password. Persons signing for the login password must be at least 18 years of age or older. Parents will be responsible for the actions of minors who are provided the login password. We will begin issuing the login password on Wednesday, October 3, 2012 at the office for anyone who is interested in this service.



LIKE FOOTBALL/SPORTS

We just received word from Oceanic that Time Warner Cable finally agreed to carry the NFL Network as part of their cable service. Effective September 23, 2012, the NFL Network is available on Time Warner Oceanic Cable as part of their Digital Variety Pak. the Digital Variety Pak is part of the cable package at the Mauna Luan and is provided free of charge to all of our residents. The NFL Network will be available on channel 203,

with the high-definition version on channel 1203. As part of the new service Oceanic is also adding the NFL RedZone to their "Sports Pass" package. For our sports followers, this package currently offers ESPN Classic, NHL Network, Fuel TV, NBA TV, Tennis Channel, Fox Sports, CBS Sports Network and the Big Ten Network, and will include the NFL RedZone. RENOVATION OF RECREATION BUILDING

USE OF TRASH ROOMS/CHUTES

Just a reminder that our trash chutes are available for use between the hours of 7:00 a.m. and 10:00 p.m., daily. PLEASE ADHERE TO THESE HOURS AS THE SOUND OF TRASH CRASHING INTO THE COMPACTOR IN THE LATE EVENING OR EARLY MORNING HOURS IS VERY DISTURBING TO RESIDENTS WHOSE BEDROOMS ARE LOCATED DIRECTLY ADJACENT TO THE TRASH CHUTE. We have also been receiving reports of some residents who regularly drop large boxes or other items inside the trash room on their floor. Please bring all items, other than normal bagged trash, to the ground floor trash bins located in the mall areas of each building. Dumping them inside the trash room means that someone else must take the time out of their day to bring those items downstairs. Also, if you turn the light on when you dispose of your trash, please remember to turn it back off when you leave to help save some electricity. Your assistance with these items will be greatly appreciated!

USE OF RECREATIONAL FACILITIES

As we have stated before, the Mauna Luan has probably the finest amenities of any condominium in Hawaii and rivals many resorts. However, being a residential community there are a lot of rules governing the use of these facilities. Due to some recent complaints that our security is being too strict, we wanted to pass on some reminders on some of the most frequent problems with using the recreation areas:

- 1. <u>Horseplay</u>. Horseplay is prohibited in the pools due to noise and safety issues. Included in horseplay is tossing children into the air, "Marco Polo", riding on the shoulders of others, play fights, etc. If you feel that your behavior should be allowed then you need to make that case in writing through the Management Office, not by harassing our security officers who are simply doing their jobs.
- 2. Water Slide. Due to safety reasons the ONLY acceptable manner of using the water slide is in a <u>sitting position</u>, <u>facing the pool</u>. That means you can't stand up, lie on your stomach or go down head first. It is also designed to be used by only one person at a time. Your help and attention to this will be greatly appreciated.
