

RE-CODING OF SECURITY KEYS

We will begin re-coding of all security keys on <u>Monday</u>, <u>February 1</u>, <u>2010 continuing through Saturday</u>, <u>February 20</u>, <u>2010</u>. The security keys are the flat metal disks that allow entrance into the buildings through the main entrance doors, parking structure doors, and also allow access to the Recreation Building facilities. This annual project does require you to bring <u>EACH</u> key to the Management Office to have a new code placed on it. Below is the schedule for the re-coding:

East Building ---- Feb 1 - 6
West Building ---- Feb 8 - 13



On Monday, February 22, 2010 we will change all of the locks to accept only the new code and no longer the old one. If your keys have not been re-coded by that time they will no longer work in the doors. Please take a few minutes and stop by to have your keys done before this date. As a reminder, the Management Office is open on Wednesdays until 8:00 p.m. and on Saturdays from 9:00 a.m. until 12:00 noon for your convenience. If for



some reason you just cannot make it to the office at the above times please give us a call and we will see if we can work out some way to accommodate you.

The cost for this service is still \$10.00 per treatment/\$40.00 per year regardless of the size of your apartment. We also have the new 2010 contract forms available

PLEASE NOTE, IF YOU HAVE NOT ALREADY CONTRACTED FOR THE SERVICE: Due to scheduling difficulties Diversified has informed us that they <u>must</u> receive your requests for service no later than Wednesday, February 17, 2010, or they will not be able to schedule you for the treatment. PARKING GARAGE SECURITY

We need to ask for all of residents' assistance with a security problem we encountered last week in the parking garage. Last weekend, there were approximately five vehicles that were vandalized by having their hood ornaments stolen by breaking them off. All of the incidents occurred on two levels of the parking structure and appears to have happened late in the evening or early in the morning. Although our security does

perform regular patrols through the garage, they cannot be there at all times so we would like to ask for your assistance. If anyone observes another person or persons in the garage who appear to be loitering and not either coming from or going to their vehicle, we would like to request that you notify security as soon as possible so they can verify the status of the individual(s) in question. This would be particularly important between the hours of 10:00 p.m. and 6:00 a.m., as most residents will not normally be in the parking garage at that time. SECURITY REMINDERS

A reminder note regarding vehicles being operated and parked on Mauna Luan premises.

- 1. All vehicles must display a valid Mauna Luan decal whenever entering the property and while parked on the property. If you do not have a decal for your vehicle(s) please stop by the Management Office at your earliest convenience to obtain one. Be sure to bring your vehicle information with you at that time.
- All vehicles parked on the premises must be in operating condition and have a current license registration and safety sticker as required by law. Our security periodically makes a listing of vehicles in the parking garage who are in violation of this rule and notifications are then sent to the owners of those vehicles. These vehicles will then need to be brought back into a legal, operating condition or they will need to be removed from the premises. If you know that you have a vehicle that falls into this category it is recommended that corrective action be taken immediately.

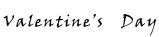
BOOK LIBRARY

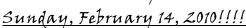
For those residents who may not be aware, we do have a reading library located in the corner of the West Lobby just before you pass through the glass doors on your way to the West Pool. This

SMOKING REGULATION REMINDER

and Hawaii State law, smoking is not permitted in the

For those residents and their guests who do smoke, please remember that due to City and County of Honolulu ordinances

Mauna Luan unless inside of your apartment or completely outside of the buildings. All building hallways, and stairwells, are also included in this restriction. Please remain in your unit or go to the ground level, outside of the main buildings, if you wish to smoke. Please also remember that there is a '20 feet' restriction that applies to the main buildings as well as the Recreation Building. That means that to smoke you will need to be a minimum of 20 feet from all windows and doorways of all buildings if you wish to smoke. Some other issues we receive fairly regular complaints about are when residents stand at their apartment windows to smoke and blow the smoke outside where it then blows into other units. We would like to request that, in consideration of your neighbors, if you smoke in your unit please do so away from the windows and doorways to help prevent a nuisance to surrounding neighbors. Your help will be greatly appreciated.
